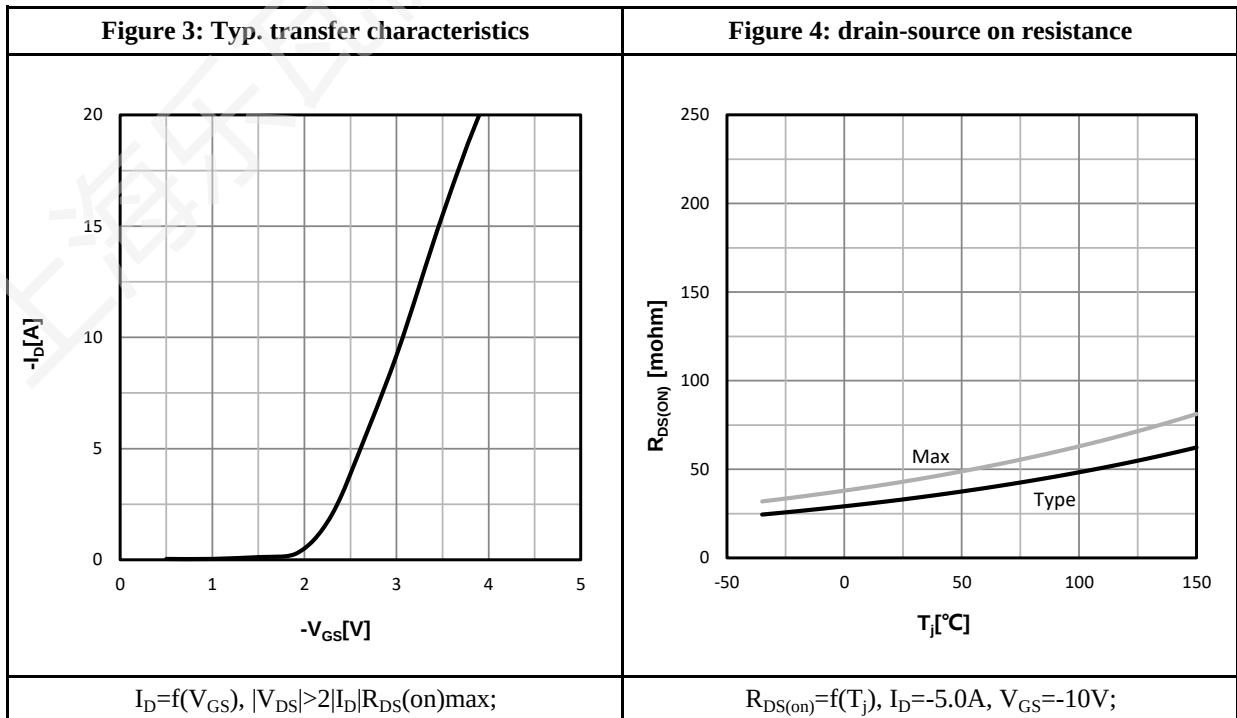

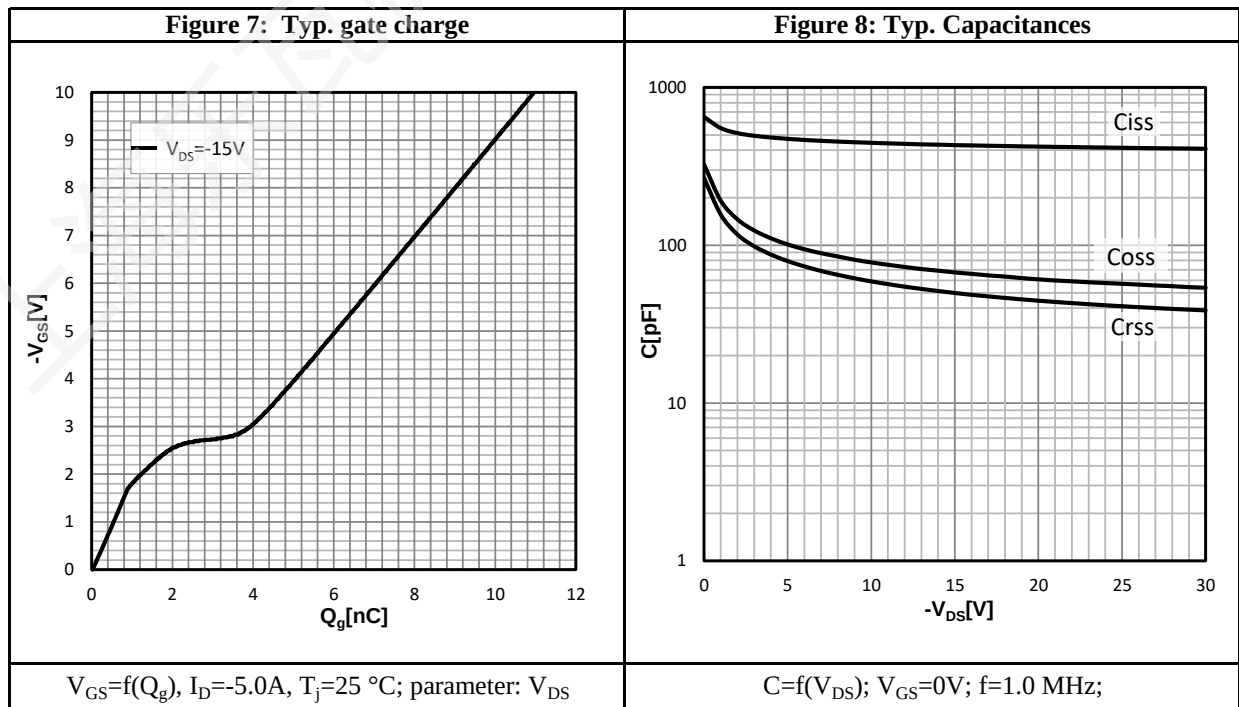

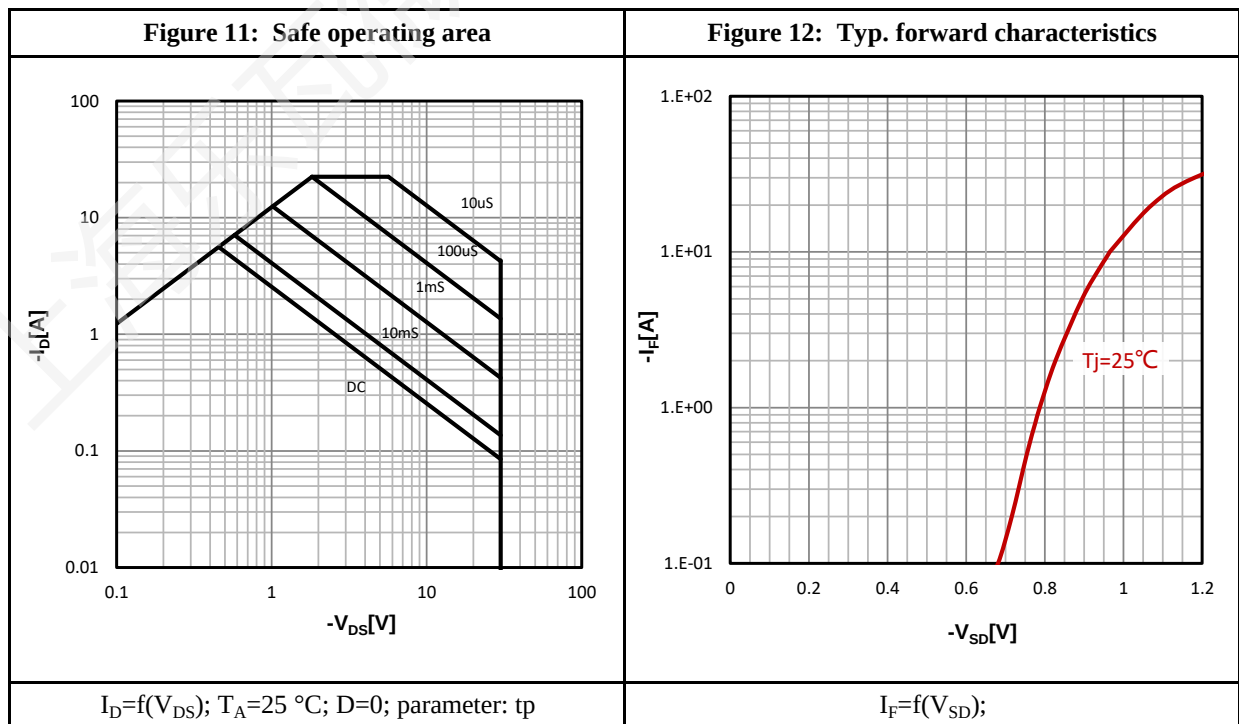
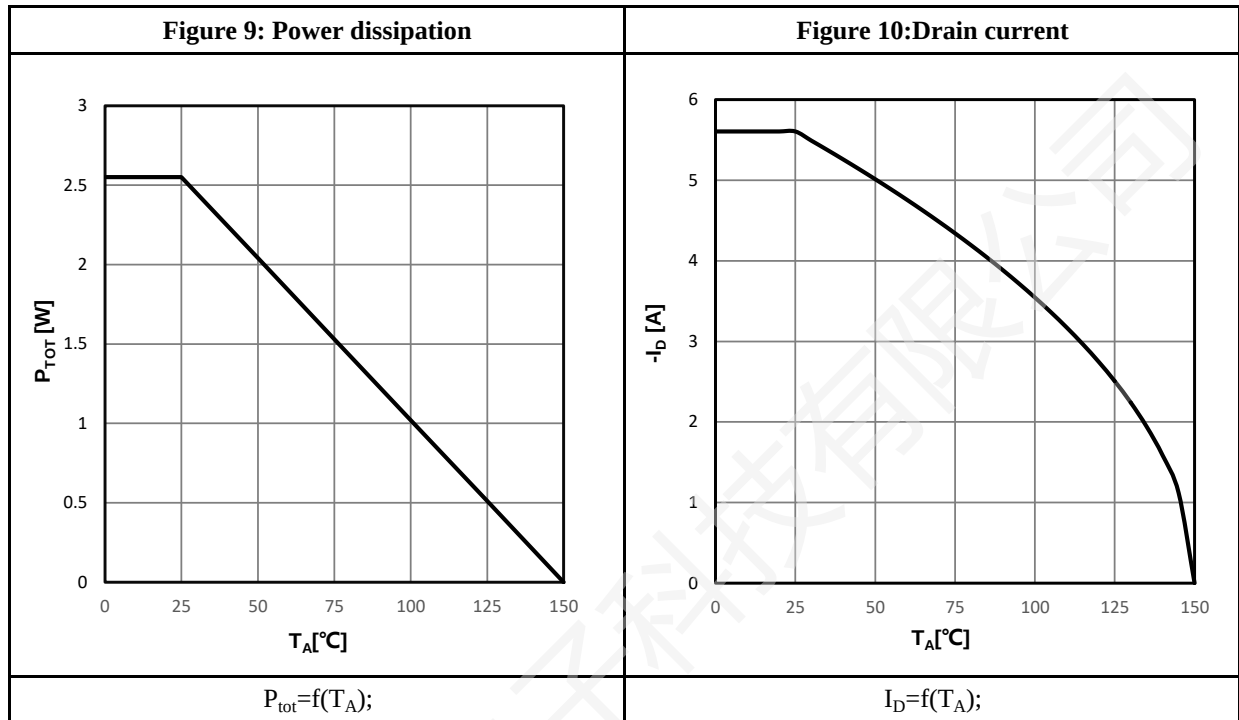
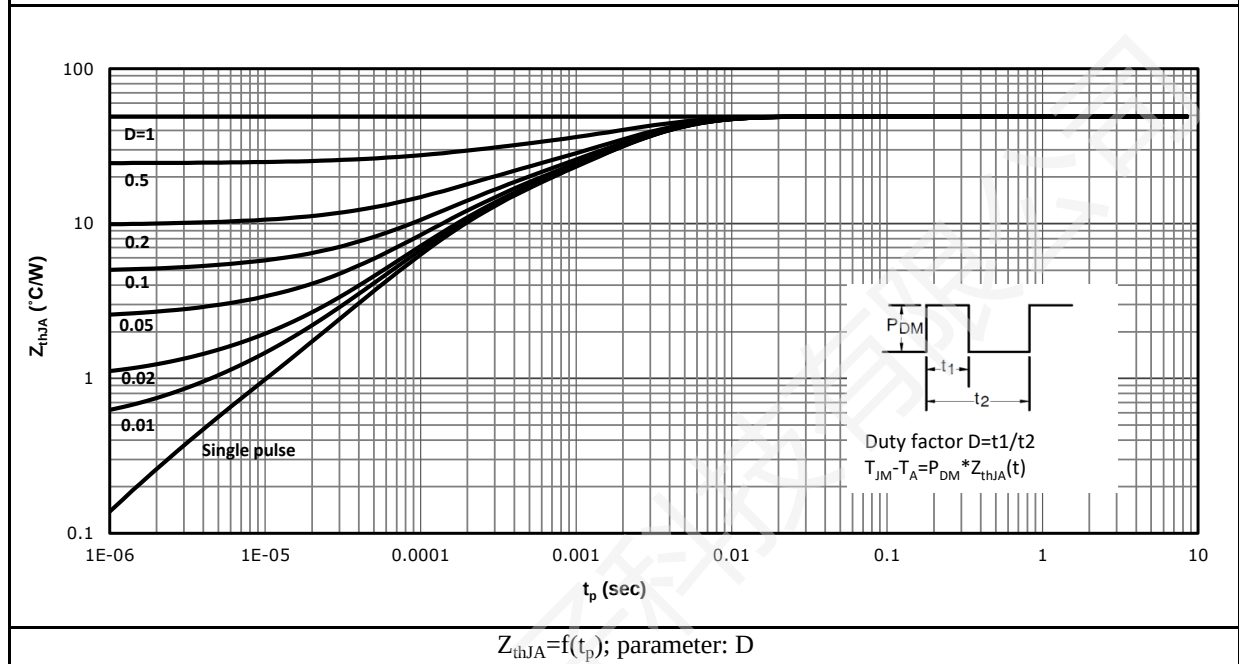
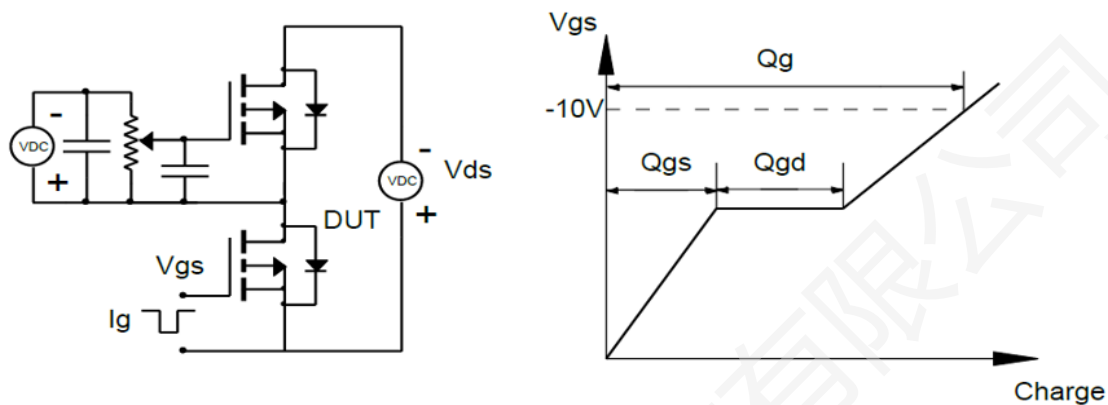
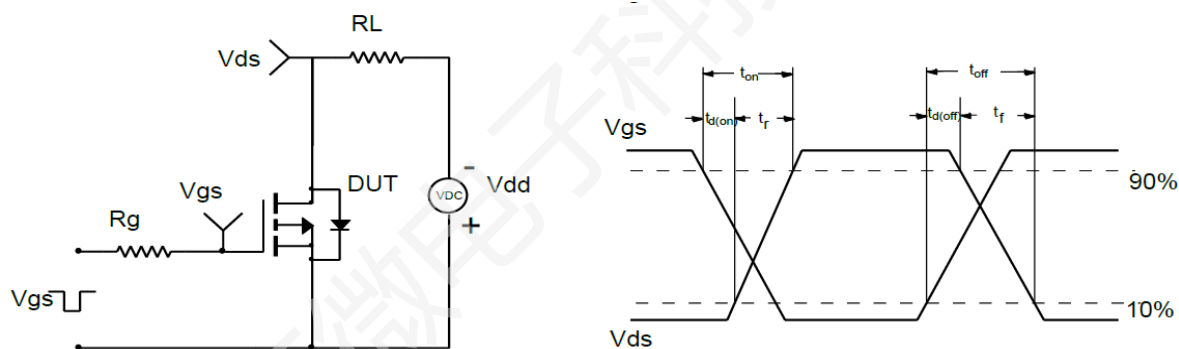
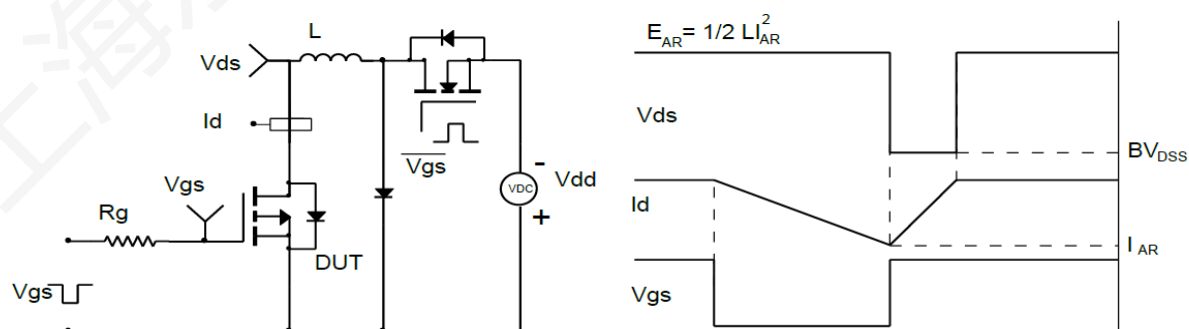
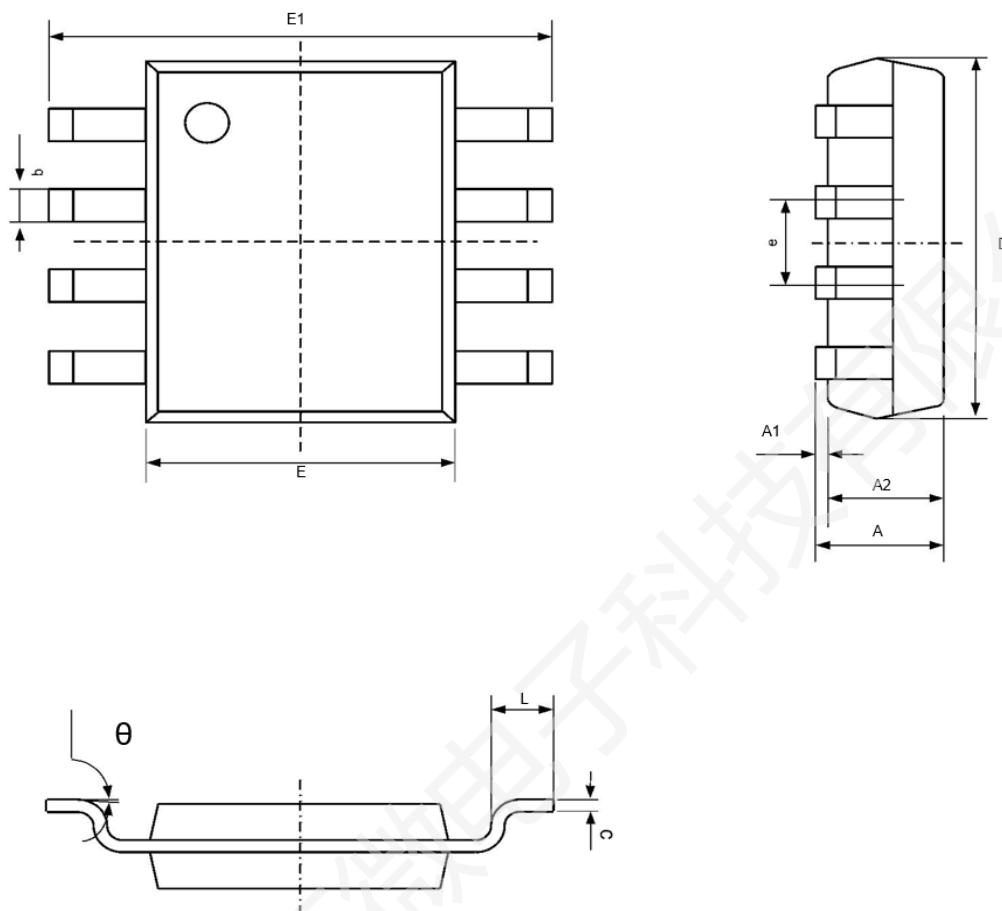


Figure 13: Max. Transient Thermal Impedance
