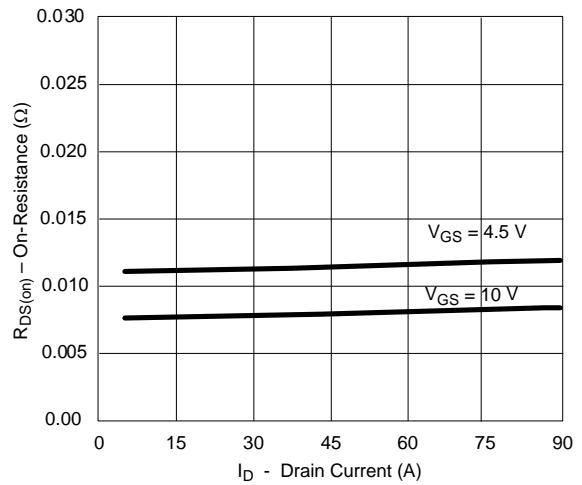

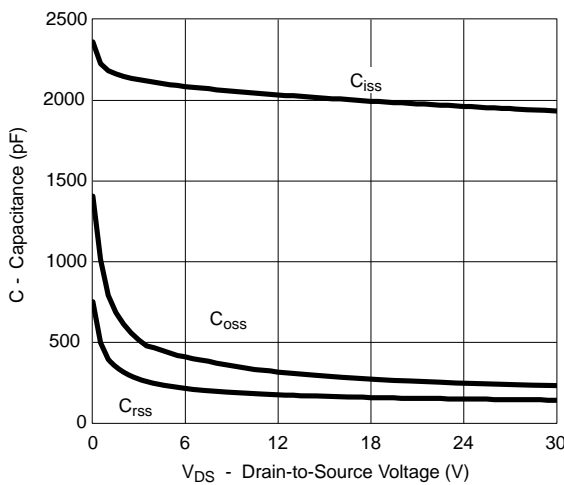

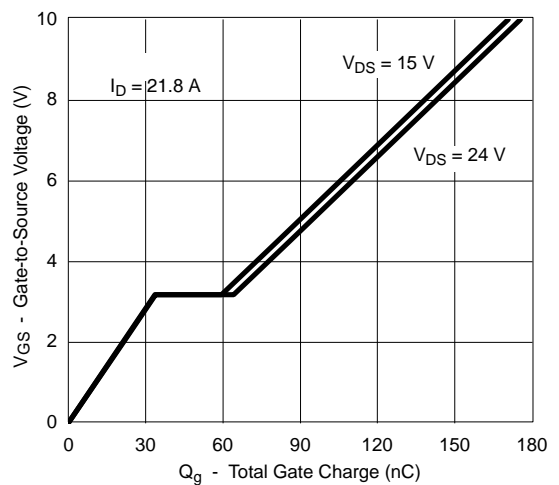
**Transconductance**



**$R_{DS(on)}$  vs. Drain Current**

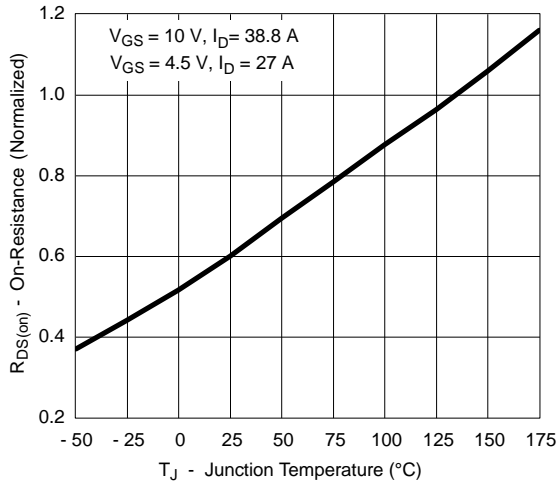

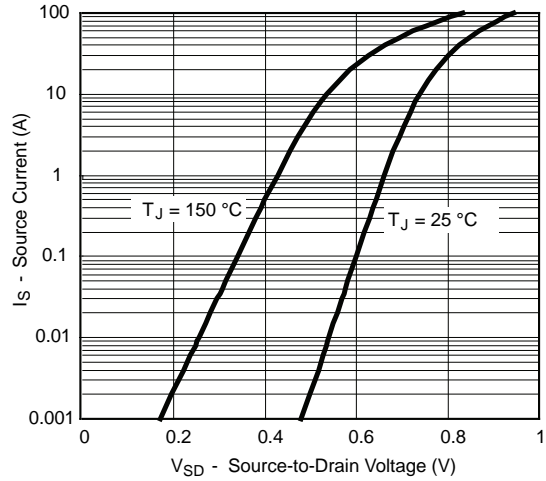

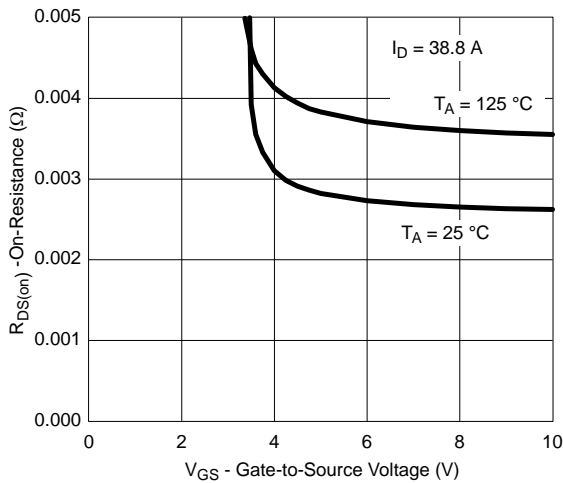

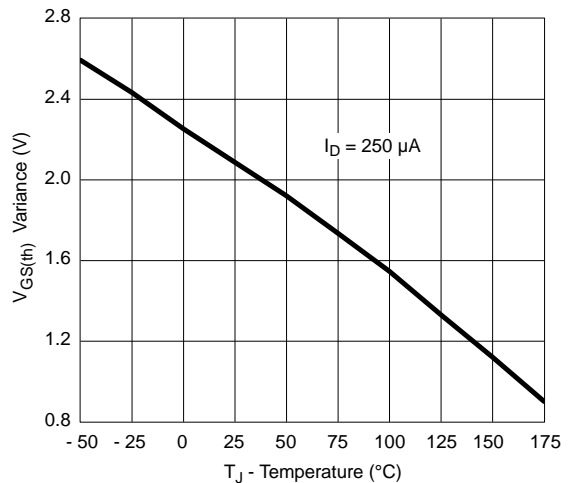
**On-Resistance vs. Junction Temperature**



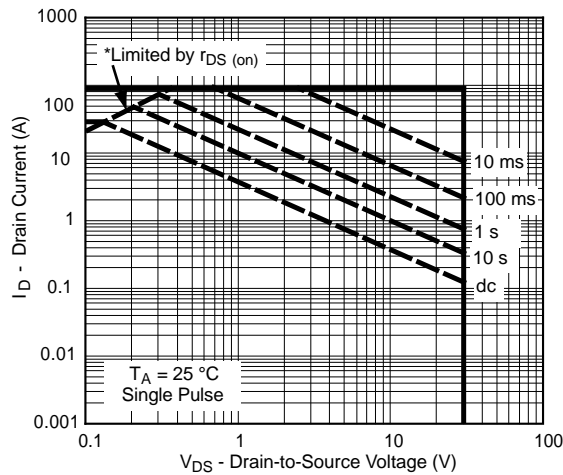
**Forward Diode Voltage vs. Temperature**



**R<sub>DS(on)</sub> vs. V<sub>GS</sub> vs. Temperature**

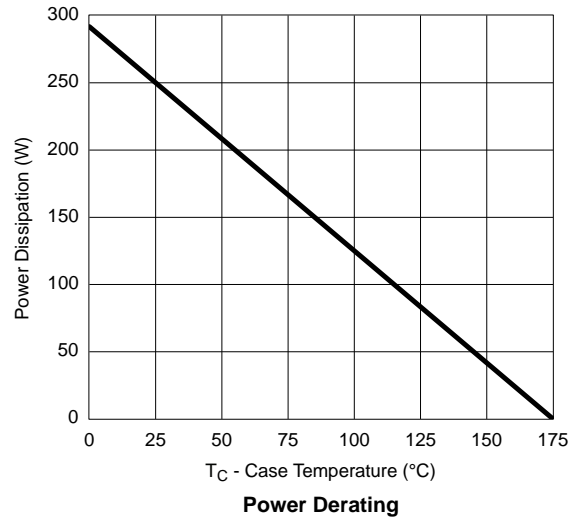
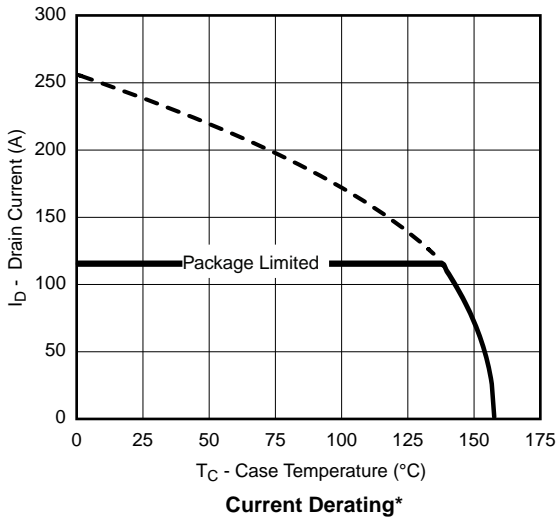
